# Buyer-Seller Consultation on Commercial Marine Craft Sutures and suture related products on 5.1.2018

Minutes of the Consultative meeting held on 5.1.2018 at 11 A M under Chairmanship of Shri A.V. Muralidharan Dy. CEO (GeM) at ISQM Hall ,Office of Government e Market (SPV), Jeevan Tara Building, Parliament Street, New Delhi regarding product category Rubberised inflated Boat.

Product category: Rubberised Inflated Boat

# Following participated in the meeting:

## **Seller's Side:**

1. M/s GEEPEE Reinforced Products Pvt. Ltd.

#### **Buyer's side:**

None Present

The existing technical parameters indicated for the product were reviewed and following points were raised by the representative from M/s GEEPEE Reinforced Products Pvt. Limited:

- 1. The technical particulars presently available indicate many parameters which are applicable for fibre glass hull boat and not for fully rubberized rescue boat. The NCD 4003 issue 6 indicated in parameter No 2 is applicable for rigid hull boats and not for inflated rubber boats and for these ISO 6185 and Indian Registry of shipping rules are applicable.
- 2. The technical particulars presently indicated for hull construction material as per serial no 3 is applicable for rigid hull boats and not for inflatable rubber boats.
- 3. The standard tool kit indicated at serial no 60 of existing parameters are covering items which are required for bigger boats with bigger engines and not for rubberized inflated boats and need to be reviewed.
- 4. The functions performed by the boat indicated in present technical particulars indicate such as boarding and landing party on own or enemy ships etc and these are not applicable for rubberized inflated boats to be used in disaster management. Therefore this may be reviewed.
- 5. The electronic horn fitted in the console as per serial no 62 is applicable for rigid body boats and not for inflatable rubber boats and need to be removed.



6. The Jason cradle parameter indicated in serial no 72 is applicable for rigid body boats used by Navy and not for rubberized inflated boats.

7. The authority regarding design approvals and facility approvals in case of all marine crafts are Indian registrar of shipping and hence their inputs regarding the technical parameters for rubberized inflated boats as well as other types of boats is required to be obtained before finalizing the technical parameters .

#### Golden Parameters proposed by participants are as under:

- 1. Conformity to the standards indicated and approvals from Indian registrar of shipping
- 2. Size of boat exterior and interior
- 3. Maximum carrying capacity
- 4. Number of inflatable chambers
- 5. Material
- 6. On board Motor fuel type, fuel capacity, no of cylinders, engine hp and other engine parameters

## As per discussions it was decided to make following deletions from existing TP:

The parameters not applicable for rubberized inflated boat to be removed .Further the technical particulars need to be discussed with representative from Indian registrar of shipping.
