

- 1. Following Golden parameters were decided based on the suggestions and discussions
 - a) Material of Tube
 - b) Inner Diameter (I.D)
 - c) Cuff Resting Diameter
 - d) Overall length
 - e) Method of sterilization
- 2. Following changes were decided in the existing TP based on the suggestions and discussions
 - a) The description of the item should be "Endotracheal Tube With Tapered Shaped Cuff With Subglottic Suction"
 - b) Parameter "Purpose of ET Tube with tapered shaped cuff with subglottic suction" is to be modified as "To prevent micro aspiration of fluid into the lungs"
 - c) No need of repeating "with tapered shaped cuff with subglottic suction " in each parameter
 - d) Material of ET Tube (Non-toxic, Medical Grade)– 100% Silicon, 100% PVC and Silicon coated PVC



- e) Sizes –7.5 and 8.5, are to be added.
- f) I.D of the tube clearly marked on the pilot balloon and tube Mandatory
- g) Cuff with one way inflation valve and Magill curve
- h) Cuff shape Barrel, Pear to be added
- i) Kink resistant thermo sensitive tube
- j) Low pressure, high volume Cuff Mandatory
- k) Latex free-Yes (mandatory)
- I) ET tube shall enable continuous or intermittent secretion through subglottic drainage
- m) Pilot Balloon-Yes and NO both
- n) Intubation depth marking Mandatory
- o) Method of Sterilization- (1) ETO, (2) Gamma and (3) Others to be added.
- p) Tissue implantation Testing certificate Mandatory
- q) Non-toxic to be deleted as it is part of the material
- r) Certification Must Declare ISO/European CE/US-FDA
- s) Manufacturing Drug License- Yes
- t) Authority of Drug License- Must Declare
- u) Drug license No. Must Declare
- v) Drug license Date- Must Declare
- w) The product should have shelf life of at least 2/3 rd of the total shelf life at the time of supply
- x) All certification to be provided to the buyer on demand
