No.FEG.9/2017/103 - The Governor of Meghalaya is pleased to notify that all the Administrative Departments and Heads of Departments, Societies, Bodies and Public Sector Undertakings etc., that fall under the Administrative Control of various Departments of Government of Meghalaya, are allowed to avail the procurement of Goods & Services on Government Market Place (GeM), an online market place under Department of Commerce, Ministry of Commerce & Industry, Government of India with immediate effect.

- 2. The goods and services made available in GeM are customized as per the requirement to the buyers, cost-effective and also has the facilities to compare with the other online market places like Amazon, Flipkart, Snapdeal to get the best competitive rates which will enhance the transparency, efficiency and speed in public procurement process.
- 3. GeM portal may be allowed to be used by Administrative Departments/Directorates for procurement of goods to be undertaken. However, it is the responsibility of the procuring authorities to certify the reasonability of rates. Further, the GeM portal shall be utilized by the buyer for direct on-line purchases as under:
 - Upto ₹ 50,000/- through any of the available Suppliers on the GeM, meeting the requisite quality, specification and delivery period.
 - Above ₹ 50,000/- and upto ₹30,00,000/- through the GeM Seller having lowest price amongst the available Seller, of at least three different manufacturers on GeM, meeting the requisite quality, specification and delivery period. The tools for online bidding and online reverse auction available on GeM can be used by the Buyers, if decided by the Competent Authority.
 - Above ₹ 30,00,000/- through the Supplier having lowest price meeting the requisite quality, specification and delivery period after mandatorily obtaining bids, using online bidding or reverse auction tool provided on GeM.

However, this shall be without prejudice to the statutory provisions contained in the existing rules, Guidelines and Office Memorandum thereunder as amended from time to time.
