2. It may be ensured that all MSE Vendors registered with CPSEs are also registered on "TReDS" platform(www.rxl.in) and "MSME-SAMADHAAN" Portal by 25th October, 2018. In this regard, it is reiterated that all CPSEs are mandatorily required to be onboard on "TReDS" and "SAMBANDH" Portal and regularly review the "SAMADHAAN" Portal for timely resolution of grievance of MSEs.
3. All administrative Ministries/ Departments of CPSEs are requested to direct all the CPSEs under their control to take necessary steps for strict compliance of the above directions.


