This addendum is made on this day of April , 2021, towards extension of the MoU dated 29.12.2017. The MoU dated 29.12.2017 was executed between the Government e-Marketplace (GeM), Department of Commerce, Govt. of India, acting through Sh. S Suresh Kumar...I.A.S, JS & ACEO, GEM, having his office at Jeevan Bharti Building, New Delhi - 110001 which expression shall unless repugnant to the context of meaning thereof include its successors and permitted assignees of the GeM.

AND

Quality Council of India (QCI), an autonomous body set up by the Govt. of India, acting through Shri. Ravi P. Singh, Secretary General, having its registered office at the Second Floor, Institution of Engineers Building, Bahadurshah Zafar Marg, New Delhi – 110002 which expression shall, wherever the context permits, includes its successors and assignees.

In pursuance of the following clause in the original MoU:

CLAUSE: VALIDITY OF THE RELATIONSHIP

The framework of the agreement would be initially valid for a period of 3 years & would be renewed after mutual review of progress. This agreement can be extended by means of an addendum referring to this agreement as the base agreement to set the revised period and terms if any.

AND WHEREAS the framework of agreement under the said MoU was valid for a period of three years w.e.f. 29th December, 2017, is set to expire on 28th December, 2020 ("EXPIRY DATE").

AND WHEREAS the parties have decided to continue the said MoU and the framework beyond the expiry date for a period of two years.

NOW BY THIS AGREEMENT the parties do hereby mutually agree to extend the said MoU and the framework on the same terms and conditions as originally set forth in the MoU till 27th Day of December, 2022, unless renewed/revised/cancelled earlier.

CLAUSE FRAMEWORK: SCOPE ROLE & RESPONSIBILITIES

Subclause (a) to (f) remain unchanged. The following subclauses are added thereafter:

- h. Research on Compliances under Products and Services
- i. Coordination and execution of online/ offline collaboration with accredited Certification Bodies/ Regulatory bodies namely BIS (offline), FSSAI, and NABL (offline), to name a few, to ensure quality in procurement.
- j. Assistance in drafting Service Level Agreements (SLAs) for various services, available on the GeM portal.
- k. Assistance in on-boarding Inspection Services/ Agencies/ Bodies on GeM portal.
- l. Quality check of vendors/service providers by validation of the certification(s) and project experience to eliminate in genuine and deceptive sellers/transactions in "Products & Services" on the portal.
 - I. Quality check of service providers by validation of quality certificate and project experience for all service providers registering on GeM
 - II. Vendor Assessment of OEMs, service providers, and resellers
 - III. Validation of Vendor Assessment Exemption (VAE)

Any additional tasks or initiatives during the contract/extension period shall be mutually decided by both parties.

CLAUSE: VALIDITY AND EXTENSION OF THE AGREEMENT

The framework of the agreement would be valid for a period of 2 years & would be renewed after mutual review of progress. This agreement can be extended by means of an addendum referring to this agreement & the MoU dated 29.12.2017 as the base agreements to set the revised period and terms if any.

All other terms and conditions of the MoU dated 29.12.2017 remain unchanged.
